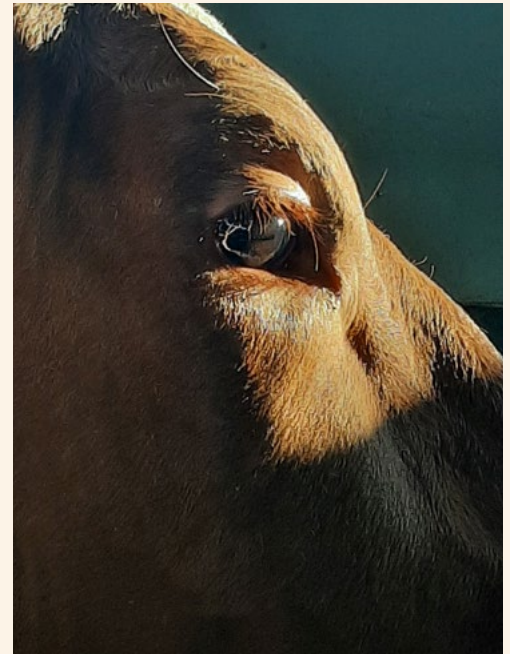

1.0 Call to Order

President Morris Bartlett called the meeting to order at 10:51 a.m. and welcomed everyone to the meeting.

- Appreciation was given to Courtney Walker, World Guernsey for her promotion of the world's finest milk through Instagram.
- Russell gave an update on the Legendairy herd sale at Christmas time.
- Christian Kaiser mentioned the opportunity to have a sale together with American Guernsey Association in the spring or at the time of their convention in July. The Canadian animals could be housed in Canada and if the buyer is Canadian, it would save the export fees and details. Robin Alden, American Guernsey Association indicated they would be more than happy to work with Canada on a sale at the time of the

national convention and purity would need to be 87.5% or higher. A sale catalogue will soon be available for the spring sale and it will be posted on their website or Facebook. There are a number of sales in the US this spring.

Paul MacLeod motioned, and Jocelyn Forster seconded to accept the Breed Improvement report and the Fieldman report. All in favour. Motion carried.

- It was mentioned there was a motion from the board meeting to increase the membership fee from \$85.00 to \$100.00.
- The deadline for the Guernsey Journal advertising is April 1st and members were encouraged to submit their entries.
- The deadline for the Breeder's Cup Contest will be May 15th. The submissions will be a 10-15 second video clip of the animal walking.
- Thierry Laberge, Semex thanked the group for being included and thanked Christian Kaiser for his efforts to inform Thierry on everything Guernsey. Thierry is looking forward to purchasing future Semex Guernsey bulls. He is interested in knowing the type of bulls the breed would be interested in using and wants to buy the right bulls. He is looking for guidance and support from the members. Members are encouraged to contact Thierry with comments and suggestions.
- Robin Alden thanked the association for the invitation. The American Guernsey association was almost shut down in 2020 but they did have one show and an All-American contest. The virtual national awards and show are available for viewing on their website and Facebook. They ended the year in the black with not having as many events. They are looking forward to meeting in person again this year. Their annual meeting will be virtual. If interested in attending please contact Robin. A two-day annual meeting in July as well as the sale will be virtual. She mentioned registrations have hit a plateau, but transfers are up. There is a decreased numbers of Guernsey animals in the US. There is a list of embryos available for sale on the private treaty site. The upcoming sales on the site will list embryos for sale as well. Sale of Guernsey milk products is high with new Guernsey producers every year. They will continue to use the Guernsey logo to promote.
- Janine Eygenraam, our registrar at Holstein Canada indicated she was happy to be at the meeting and she looks forward to receiving the updates. The imports from the US having been taking up some time and happy to see the Guernsey breed growing in Canada. It was special to be able to approve a couple

of Guernsey bulls for AI and some new family bloodlines. Guernsey registrations and transfers are going well and are returned to the owner within a couple of days. Any questions or comments can be directed to Janine. Jim thanked Janine for all her work with the Guernsey breed. There was a question on whether Guernsey photos can be added to the registration paper. A photo of one side of the animal would be best as there is only so much room.

- Jim Eby mentioned they will be adding A2 labeling to their milk bottles and currently waiting for approval. The cows at the farms of Christian Kaiser and Jim Eby have all been tested for A2.
- Morris Bartlett thanked everyone for joining the virtual Annual General Meeting and reminded the board members of the meeting at 1:00 p.m.

PRESIDENT'S ADDRESS



Welcome Guernsey breeders and friends to the Annual Meeting of the Canadian Guernsey Association for 2021!

This will be our second virtual AGM and our first AGM facilitated by Holstein Canada. In January 2022 we entered into a contract with Holstein Canada to assume the administrative duties for the Canadian and Ontario Guernsey Associations.

In December of 2021 our contract with EastGen as our administrator ended as they no longer had the staff availability to continue the work on behalf of Guernsey. We deeply value the relationship that we had with EastGen and in particular with Jessie Weir. I would like to thank Holstein Canada for their willingness to take on this new role. We will be working directly with Linda Markle and Nicky Barnard and we look forward to developing our relationship with them.

EastGen has agreed to continue to invest our savings with Burgundy, which is a great benefit to Guernsey.

2021 had its share of frustrations with the COVID-19 pandemic and all the ramifications it caused, but it was a very positive year for the guernsey breed. The dispersal of the Maplehurst herd caught the attention of the guernsey world and created an opportunity for others to acquire high quality guernsey cattle.

We have the establishment of a new guernsey herd in Ontario as well as other farmers adding guernsey cattle to their herds. We are currently living in a seller's world as the demand for guernseys is greater than the supply. Our challenge is to grow our heifer population and to continue to develop guernsey cattle that will appeal to all dairy farmers.

ADMINISTRATION REPORT 2021



The pandemic and government restrictions continued in 2021, cancelling initiatives, events and shows which would normally promote the Guernsey breed. Your Guernsey Board of Directors remained positive and focused on items which were possible to complete.

A few of the ventures; were putting goals in place for the breed, revamping the constitution to provide clear direction for the future of the breed and finding a new home for the administration of the office. As a reminder of the goals set, they are listed below. I encourage each and every one of the members to review and work toward these goals for the betterment of the breed.

Goals for the Guernsey Breed:

- Increase the number of members to 75 over the next three years.
- Increase the number of registrations to 500 per year over the next three years.
- Increase national average production to 375 kgs

- butterfat and 275 kgs protein by 2026.
- Increase the number of Guernsey animals available for sale through expanded use of embryo transfer, IVF, sexed semen, and cattle sales.
- Continue to support and encourage production of Guernsey dairy products by assisting producers to access high quality genetics. Continue to market the quality of the Guernsey cow, especially her milk.
- Increase the number of animals in the breed genomic tested and classified.
- Reduce and eventually eliminate monetary dependency on investment income.

Later in the year, EastGen made some organizational changes due to a retirement of a staff member. The re-organization involved me taking on new responsibilities as the Executive Assistant to Brian O'Connor and the EastGen Board of Directors. The change meant EastGen would not be able to provide services to the Association in the future. I have truly enjoyed the last 11 years working with the breed.

The Guernsey breed is in great hands with the administration and office now at Holstein Canada. A special thank you to Linda Markle, Nicky Barnard, Colleen Sykes, Janine Eygenraam, Pat Hill, and Jim Eby for all their help with the transition of the Guernsey office to its new home in Brantford.

In closing, thank you to the Board of Directors, Russell Gammon, and the wonderful members of this Association for this tremendous opportunity. I wish the Guernsey family, very best wishes for an amazing future.

BREED IMPROVEMENT COMMITTEE REPORT - 2021



Other than it's over, I don't have much good to say about 2021. For the first time since I have been a member of the committee, regrettably we did not have a meeting since my last report. We had planned to meet with a Holstein Canada classifier on farm but due to COVID-19 restrictions that did not materialize. The committee has been monitoring the classification reports and hopefully a meeting will be set up shortly. The average Guernsey 2-year-old classified 80.53 points last round and a couple of the most common defects identified by classifiers were advanced tailhead, weak crops and toes out front. Members have of course been involved in regular board meeting and some committee members have been involved in updating our constitution.

Guernseys are still in high demand so I hope everyone is considering all their options when producing the next generation. Now is a great time to genomic test your top females and flush them or breed them with sexed semen. Studs have a renewed interest in the Guernsey breed and are providing more high-quality bulls with at least 3 studs providing sexed semen. To my knowledge, Masterpiece

genetics are not yet available in Canada. My local distributor says the import charges would make the price of the semen too high based on projected sales. Semex, GGS (ordered through Select), ABS and ST all have semen readily available. Semex would like our input into the bulls they purchase so if you know of a bull or cow family you would like to see a bull from please contact a committee member for further discussion.

Also, I thought I'd remind you about the CDN website. It provides a wealth of information to help you with mating and management decisions. You can look up female and mate indexes or pedigrees as well as use the inbreeding calculator. You can even make your own customized LPI formula.

Hopefully 2022 will bring us all closer together and we can enjoy some time together at farm tours, meetings and shows.

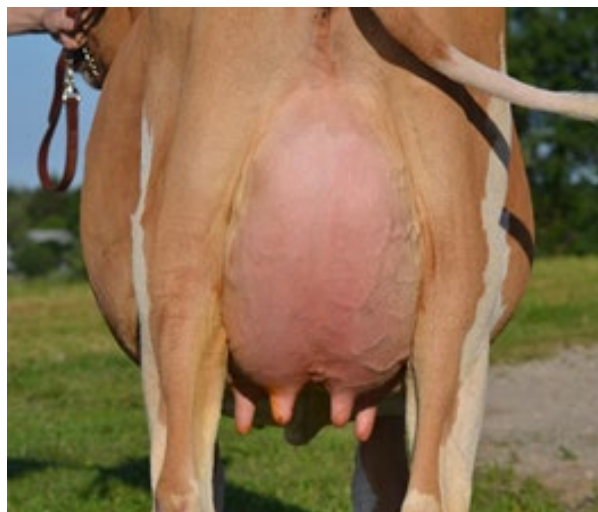

Demand for Guernsey milk translates into direct demand for Guernsey cattle! It is exciting to see the steady, consistent, growing demand for all manner of Guernsey genetics-we've recently been responding to queries about Guernsey milk cows for herds who already milk some golden cows, herds who want their first Guernsey heifers or cows, pursuit of a Guernsey or two for family cows, embryos-and in specific embryos made with sexed semen. The highly, highly successful Maplehurst sale and associated private sale of cattle from that storied herd proved that there is mega demand for Guernseys in Canada AND that our American Guernsey counterparts are keen on high end Guernsey genetics from Canada! It was amazing to see how many people expressed interest in the breed before the Maplehurst sale!

This demand springs from demand for Guernsey milk as the number of companies working with Guernsey milk grows. And demand for the products they create grows!

We welcome a new on-farm processing company in Promise Valley Farm and Creamery on Vancouver Island in British Columbia!
