Annual General Meeting Canadian Guernsey Association Thursday, March 27, 2014, EastGen, Guelph, ON

1.0 Call to Order

President Scott Gordon called the meeting to order at 11:09 a.m. and welcomed everyone to the meeting.

2.0 Approval of Agenda

The agenda was reviewed.

Morris Bartlett motioned and Jim Eby seconded to accept the agenda. Motion carried.

3.0 Review of previous Annual General Meeting Minutes

The minutes of the previous annual general meeting held on Thursday, March 28, 2013 were reviewed. Morris Bartlett motioned and Ken Forster seconded to accept the minutes. Motion carried.

4.0 Business Arising from the Minutes

5.0 President's Address

Scott Gordon presented the president's address as printed in the annual report.

6.0 Administration/Financial Report

 Jessie Weir presented the administration report as printed in the annual report and gave a detailed report of the finances.

Paul Noble motioned and John Gordon seconded to accept the administration/financial report. Motion carried.

7.0 Breed Improvement Committee Report

- Scott Gordon presented the breed improvement committee report as printed in the annual report.
- There was discussion on the changes to the British index system. The new index will add negative weightings to a few of the traits. The Isle of Guernsey has adopted this new system for Guernsey. The general feeling was this is the wrong path for the breed.
- In a small breed, using genomics is not as accurate with only bulls included. There is talk that all females will need to be tested in order for the accuracy to improve. There was discussion on whether members would support having all their animals genotyped before registration would be allowed. As we will never have the same reliability as the larger breeds, is it worth the expense to continue on this path with little genetic improvement?
- AI units are now marketing A2:A2 bulls. It was felt we need to continue to promote the A2:A2 bulls however if there is a good A1:A2 bull we should still continue to market.
- There are 4 lines of polled genetics in the UK for Guernsey. It was felt polled wasn't as important as A2:A2.
- The national herd average for production was reviewed. Even though the breed lost some in milk, the breed continues to improve in Fat and Protein percent.

8.0 Promotion Committee Report

• Scott Gordon (in the absence of Amy Lindsay) presented the promotion committee report as printed in the annual report.

9.0 Fieldman Report

- Rob Forster presented the report as printed in the annual report.
- The young sire program is at the forefront of Board discussions. A royalty program with Semex looks very promising. Russell Gammon will be inspecting the initial bull in April. The program would include 15-20 syndicate members at \$250 per member which would include 15 doses of semen. Semex would be responsible for the trucking, collection and selling in other countries. The association would be responsible for buying the bull, organizing the syndicate members and marketing. The bull, Lindrian Grumpy Pilot would likely be health tested in April.
- Gold Star Breeder Award might need to be reviewed and revised. The award at Holstein has changed recently
 and we might want to compare the two awards. For this award, herd size might need to be reviewed as there
 aren't as many large herds.

The meeting broke for lunch. Scott Gordon asked Jim Eby to give the blessing. Scott Gordon thanked Nancy Gordon and Cathy Noble for the wonderful desserts for lunch.

The pictures showed beautiful landscapes, gorgeous Guernsey animals, breathtaking coast lines, quaint towns and very narrow roads. Scott Gordon thanked John for his presentation. John was given a Guernsey vest as a thank you for his presentation.

Update on our Facebook page and group; the page now has 636 likes with farms posting their own pages on it, networking at its finest. The group now has 77 members with discussions started by photos post by our members about pedigrees on the animals in said photo an excellent form of promotion without the cost of putting an Ad in a paper down south.

The breed once again has been in the public's view by having animals at the Canadian Dairy XPO with a draw for 5 doses of Lindrian Grumpy Pilot (our syndicate bull). We hosted the annual Canadian Guernsey National show in Ancaster last September with animals all the way from Keswick Ridge NB. Many first time visitors to the fair came to pet the girls (my favorite part of fair season). The Canadians were represented this year at the International Guernsey Show in Madison by a heifer from the Gordon Family of Keswick Ridge, NB (Guernsey View Wii's Amy).

I would also like to thank Eby Manor for representing and promoting the breed with their hard work in promoting their Guernsey milk products. This fall they introduced CHOCOLATE milk! Keep up the good work!


If you happened to watch "Inn-vasion" on the Cottage Life channel they have mentioned using Guernsey Cheese from the Upper Canada Cheese Company, in their recipe used in a makeover of an Inn in Stratford. Free promotion is always good.

We all need to keep in mind that promoting the breed, selling our animals and keeping our farms open to visitor's is your way to help keep the breed going in a positive direction.

With my second show season under my belt now, I've come to learn/realize that some people are afraid to ask you questions while others have no boundaries. Having a nice clean display with information on it helps those who will not approach you while those without boundaries require having someone 'on deck' at all times to answer questions or tell people of the dangers of walking up to a mature cow. We all need to keep in mind that what we say and do at fairs is what most of the general public base their opinions of farmers on. Keep up the good work fellow fair goers!

With our move to Holstein Canada for registrations, it is my hope that this will help those who buy into the breed to keep registering their animals, as it will be just as easy to register Guernseys as it is Holsteins.

Amy Lindsay Promotions Committee Chair The Breed Improvement committee met Feb 6th at Eby Manor Farms. Present were committee members Jim Eby, Rob Forster and myself as well as classifier Carolin Turner. We spent a couple hours evaluating 2 year olds and discussing the different breakdowns and measurements while looking at the results from the previous classification rounds. One area of concern is the rear udder height measurement. We have an extremely high number of cows scoring 8 and 9 which doesn't leave much room for improvement. Carolin is looking into the effect of changing our rear udder height measurement by 1/2 - 3/4 of an inch but has yet to get back to us.



Carolin also thought we should consider putting more emphasis on heel depth and taking it away from foot angle as it can be manipulated through hoof trimming. After further discussion we agreed to flip the weighting for heel depth and foot angle on the classification score card.

In the future we will be evaluating the LPI formula, following any new information on genomics and looking for ways to improve the Guernsey breed.

Fieldman Report

Canadian Guernseys take a back seat to no one! The educated consumer has realized our Golden product is superior to other milk on the shelf and the educated breeder has realized that the Golden girl is a solid alternative to other dairy breeds. In the past year we have seen Eby Manor add chocolate milk to their product list to the delight of the public. Many requests have been received for animals of all ages with some being filled. We also brokered embryo sales to Australia. I thank the breeders that have made animals and embryos available but more animals are needed to fulfill the demand.

The largest Canadian Guernsey success story of 2014 is that of the Gordon family of New Brunswick. Guernsey View Wii's Amy travelled to our National Show in September to be named Reserve Junior Champion and then carried on to World Dairy Expo in Madison, WI to place third in a strong winter calf class. However, this is not the end of her journey. Amy then topped the Guernsey Expo sale at \$8000 and found a new home in Gackle, ND where her story continues.

Our National Show was truly national as the Gordon family became our first out of province exhibitors. The quantity of animals was slightly lower but the quality ever improving. Judge Seth Johnson did a commendable job placing the 53 head paraded before him. There was also a strong class of 13 junior show people which bodes well for interest in our breed. I would like to thank all of those that take the time and effort to make the show a success.

The Third Annual Ontario Breeders Cup took place in the spring of 2014. Bryan Smith was the judge for the event in which he had to endure a day and half in a car with me. With the help of some pictures and notes, Bryan expertly placed the 8 first lactation animals and the 6-3+ lactation animals from 7 breeders. Thank you to Bryan and the breeders that accommodated us.

The Canadian Dairy Xpo gave the Association an opportunity to be a part of a huge dairy showcase. Over 2 days, we interacted with dairy enthusiasts and breeders to discuss the Guernsey breed and issues that affect us all. In addition, Eby Manor Guernsey milk was sampled by many Xpo participants with great results and responses. We also promoted the Guernsey cow in the EastGen display at the Outdoor Farm Show in Woodstock.

Lindrian Grumpy Pilot-ET represents the first bull to be released through the newly formed Canadian Young Sire Program administered by the Canadian Guernsey Association with the assistance of Semex. His semen was officially released November 1 to countries worldwide with the exception of the European Union countries which will be delayed until late Match.

I would like to thank the breeders and Jessie for their support over the past year for helping to keep the Canadian Guernsey Association on the right track.
