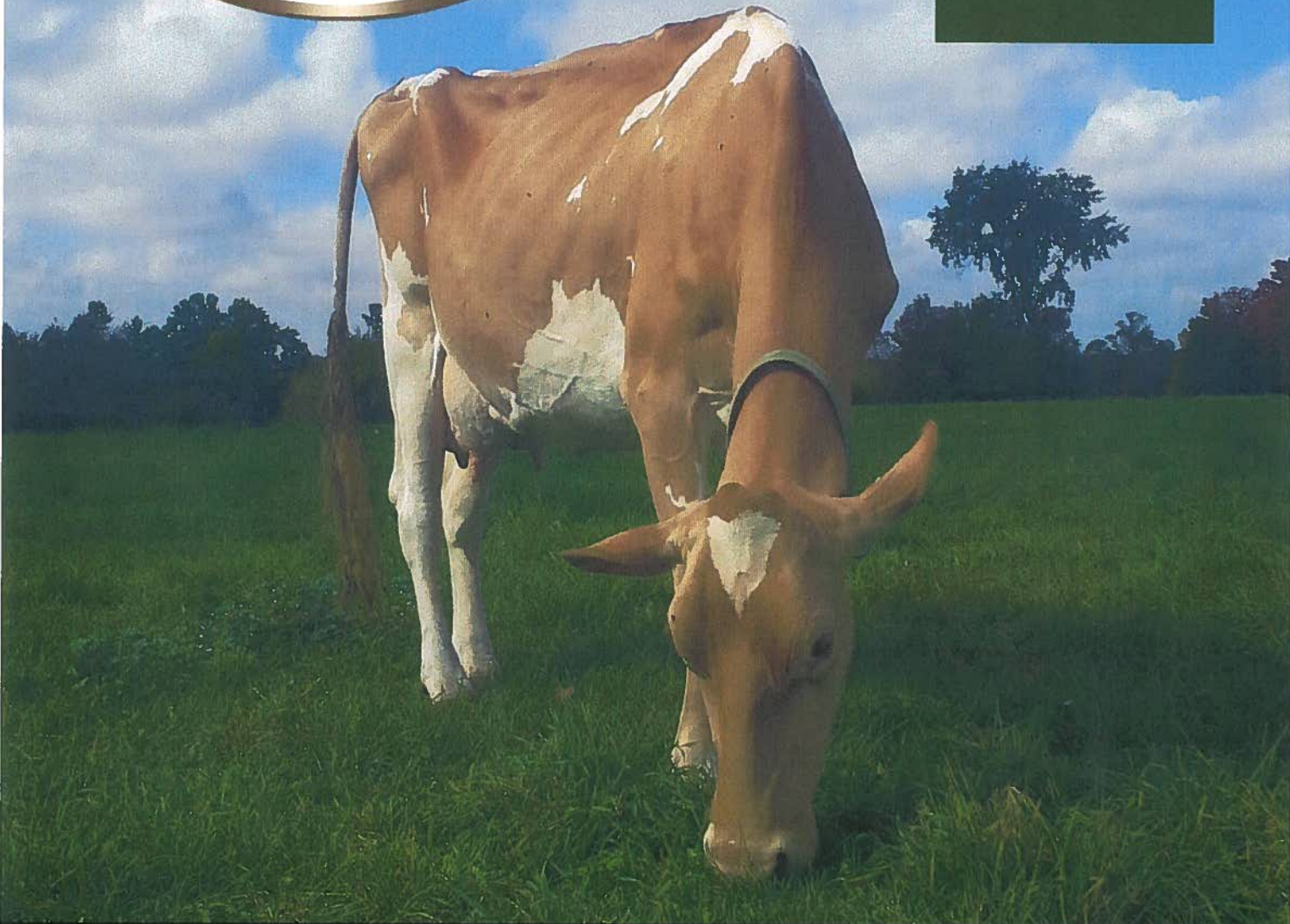

Ken Forster invited Linda Markle from Holstein Canada to give her presentation. Linda Markle introduced herself. She has been with Holstein Canada for more than 35 years and brings a great wealth of knowledge to the herd book service division. Linda is the Manager of Herd Book and Genotyping. Her responsibilities lie with the herd book, customer service and genotyping service. She has 25 staff in her department which at one time was a staff of 40. Due to efficiencies Holstein was able to see a decline to 25. The new herd book project has been in discussion for a number of years. The project involves animal and client management to carry out herd book services. There is a suite of software programs interacting between people and a central database to improve tracking, monitoring, controls and research tools. With the new project there was a wish to expand into various areas – web services, mobile platform, web interfaces, other breeds, integration with industry partners. Linda spoke about the different phases of the project. As Holstein begins moving the Guernsey breed to the new system, they will be asking for any wish list items in order to incorporate these into the new system. Holstein currently processes 1000 registrations per day. Linda answered a number of questions which was very interesting and informative.


Ken Forster thanked Linda Markle for her presentation.

Following Linda's presentation, Ken Forster gave the blessing and lunch was served. Following lunch a fun auction was held to raise money for the association.

Breed Improvement Committee Report - 2016

Greetings. As in years past I will try to update our membership on the activities of your Breed Improvement Committee since our last annual meeting.

There have been a couple changes made to the proof sheets we receive from the bull studs. Firstly, Semex has identified the popular bull Kakadu as A1A2. His change from the previously advertised A2A2 status has greatly diminished his global sales. Secondly, as of August 2016 CDN has removed Pin Setting and Set of Rear Legs from the proof sheet as the same information was used to establish the Rump Angle and Rear Legs Side View values.

The committee has looked at a couple more young sire pedigrees for our syndicate program but as of yet there is nothing that fits all of our requirements. ABS has a new young sire available, Lucky Cow Boy, and has imported semen from the UK. This is the first bull they have made available to us in many years so hopefully he proves out well for them. Trewey Victor Ezekiel is another UK bull that we are watching as he is scheduled to be in stud now and hopefully producing exportable semen. He ranks at the top of the MACE LPI list.

As we looked over the results from the last 2 classification rounds we averaged 1%F, 22%G, 60%GP and 17%VG on the first classification of first lactation animals with approximately 2% moving up to GP or VG when reclassified during their first lactation. The top defects flagged by classifiers continue to be high tailhead and weak crops with weak pasterns taking a jump up this last round. During our next committee meeting we plan to have a classifier present to ensure the measurements being used accurately reflect our breeding goals as we are still questioning our rear udder scores.

There are a few issues the committee is currently researching. We are still in contact with Cogent Canada to see if they are interested in providing the Canadian breeders with Guernsey bull semen. Also we have contacted DHI to see what information can be gleaned from their wealth of numbers that might set the Guernsey breed apart. Lastly we have started a conversation on our LPI formula, its relevance and reliability.



FINANCIAL REVIEW


TO THE MEMBERS OF THE CANADIAN GUERNSEY ASSOCIATION

Fieldman Reflections

The Guernsey Association continues to be involved in area events in order to maintain a presence in dairy industry circles. Once again we took part at CDX live animal display in Stratford held on April 6 and 7 along with Eby Manor Guernsey chocolate milk provided to visitors. Our participation in the Ontario Inter-County Dairy Judging Competition is another example. By providing a class to be judged by 4-H members (who are our future dairy producers), we have exposed them to a quality breed that could be an option for their herds down the road. I would like to thank Murray Reissner for his continued support of the Guernsey breed and opportunity to showcase our breed. The Guernsey breed is an attractive alternative to the younger generation. There has been increase in the number of 4-H members that have chosen Guernsey calves as their 4-H calf projects.

There have been several inquiries from across the country and these orders will be fulfilled in the spring when the weather is the more favourable.

Our inaugural young sire entrant continues to receive accolades. Lindrian Grumpy Pilot was the sire of the junior champion from International Dairy Week in Australia. He continues to receive a high praise for conception rate. This is a trait that makes him an attractive option for all breeds. His daughters are expected to be milking in the late summer or early fall. We are always looking for the next entrant into our program that can be attractive to breeders worldwide and help advance the breed. The newest bull available is Lucky Cow Boy who has been imported by ABS.

The sale of 34 A2A2 milking and bred animals from Rob Beynon's herd to a breeder in Ohio that is the exclusive supplier to Origin Milk who specializes in Guernsey A2 milk has been completed. Seven additional animals have been sold to existing Guernsey breeders and a heifer from Comfort's was sold to Bruce Fuller (former/new breeder) for his daughter to show in 4-H.

Milk Quality and Food Safety has been already implemented with Animal Care and Livestock Traceability beginning in September 2017, Biosecurity in September 2019 and Environmental Sustainability in September 2021. For more information visit the DFO website under Farmers to find the ProAction tab which is loaded with information as well as frequently asked questions.

This year's National Show was judged by Berneta Gable. There were 51 head shown by 7 exhibitors. Frank Robinson was on hand to photograph class winners and portraits following the show. Marie McNabb was our ring announcer, Jessie Weir recorded the official placings and Harry Emmott offered his services as our ringman. Thanks to all.

Unfortunately, this past year has seen the dispersal of 2 Guernsey only milking herds which will put a large dent in our numbers going forward. Also, there was a sale of another herd which is remaining Guernsey and have added one new breeder. As a breed we will continue to have challenges but with the unique characteristics of our milk strides can be made. Milk with A2A2 Beta Casein continues to be an element of our milk that gives us an advantage and Eby Manor has used this fact to their advantage. Progress of our breed depends on the marketability of our milk!
