2010 Administration Report

What a busy year 2010 has proven to be for the Guernsey breed. Hosting the World Guernsey Conference was a tremendous opportunity to showcase your breed, herds and farms to the rest of the Guernsey fraternity around the world. Congratulations on a job well done! It has been a great experience meeting and working with many of you either at the conference, National show or at various meetings. The passion your membership has for the Guernsey breed is very evident and shows in your commitment to promoting the Guernsey cow. Thank you and congratulations to all the exhibitors and sponsors who continue to support the National Show and the various Guernsey shows throughout the year.

A total of eleven cows made the Superior Production list for over +460 kg for butterfat based on the 2010 production records and four animals over +360 kg of protein. Four of the eleven animals on the butterfat list are owned by Kenneth McNabb. On the butterfat list the top two cows Maplehurst Romeo's Beth (VG-87) and Lindrian Garrett Pippy 465 (EX-92-2E) surpass the cutoff in a huge way. Beth hit the number one spot with a record of 3 Yr 9620 688 7.2% 314 3.3% and Pippy 465 second place with her record of 4 Yr 11008 650 5.9% 366 3.3%.

There were a total of seven animals to make the 2010 Honour Roll list for butterfat and two of these individuals came in at first place for their age class - wow! Again the three year old record by Beth and the four year old record of Pippy 465 gave them trophy status. Another notable cow was Coanwood Suzanne (G-71) who hit the Superior Production list for butterfat and protein as well as the Honour Roll list for both butterfat and protein with her 4 Yr 11039 483 4.4% 381 3.5% record. Lindrian Magicman Poppy (GP-80) and Glen Haven Double Bubble (VG-85) also hit both classes in the Superior Production category.

What an accomplishment for Lindrian Farms, Surrey, BC who took top honours by winning four of the breeder sponsored awards, Ran Don Farms Ltd Award for highest milk herd average (kg), the Lindrian Farms Award for highest butterfat herd average (kg), the Chinook Crest Dairy Award for the highest protein herd average (kg) and the Lindley Farm Award for the highest composite breed class average. Eby Manor Farm and Maplehurst Farm once again qualified for the Gold Star Breeder Award. With Eby Manor Farm receiving their fifth Gold Star Breeder Award, they have qualified as a Master Breeder as well. Congratulations to all the owners of the wonderful Guernsey cows honoured on the production award listings and in the show ring, with far too many to mention individually. Please take the time to review the award winners and congratulate each of them for their accomplishments.

With registrations continuing to gradually decline it is important to continue to register and transfer your animals in a timely manner. When questions or concerns arise please feel free to contact the office. It has been a pleasure working with the Board of Directors, the members and the entire Guernsey breed. I look forward to the exciting opportunities that lie ahead for the breed in 2011.

FINANCIAL REVIEW


TO THE MEMBERS OF THE CANADIAN GUERNSEY ASSOCIATION

Breed Improvement Committee Report - 2010

Our National Herd average for 2009 was slightly lower for Kgs of milk and protein from the previous year. However in 2009 we achieved the highest BF test that we have seen in the last 10 years, which did result in an all time high for Kgs of butterfat. Feed quality in 2009 was probably a factor in some herds for the lack of overall production gain.

Guernsey classifications are holding pretty consistent with the years in which the largest number of cows were scored.

The directors reviewed the classification statistics and noted that the greatest improvement in the latest classification round was in rear udder width.

The consensus of the directors is that our system is currently serving us very well and that there is no need to make any changes to our program at this time

Fieldman Report

This past year has been full of “Golden Moments”, from the Olympic performances in Vancouver to the World Guernsey Conference from coast to coast. As Canadians and Guernsey breeders we can be proud of the manner that we represented our country.

1. Ontario breeders continue to support the Blue Halter Sale in April by consigning 6 animals with a part of the proceeds going to the Ontario Association.
2. The World Guernsey Conference in July was a well planned effort and I was proud to represent the breed during the Ontario and Eastern Canadian portions of the tour.
3. The National Show once again showcased the top Guernseys and it did not disappoint with a well balanced 2 yr old named Grand Champion.
4. A couple of weeks later at the Rockton Fair, Guernseys made a return to the ring after a lengthy absence - another opportunity to showcase our breed.
5. We were able to help prove 3 new sires through the Semex young sire program with 4 more introduced, including a “Designer Series” addition from the 2007 World Dairy Expo Supreme Champion Pistachio Pie. Another son of Pistachio Pie by Challenge was also released this past year by ABS. Genex and Select Sires also provide a great selection for Canadian breeders. There were a total of 14 young sires (11 in 2009) from North America’s top genetics released in 2010 among all the AI organisations to choose from.
6. The Canadian Guernsey Journal continues to be a World class publication.
7. Income from registrations and transfers has increased over the last 3 years by 30%. Unfortunately, due to our smaller breed, this percentage is a little deceiving although encouraging.
8. The breed has been able to maintain new registrations numbers over the last 3 years.

The points previously mentioned are a credit to the Guernsey Association, but there is always room for improvement. The time is right to set achievable goals. We need to take what we have learned from the World Guernsey Conference and make it happen – turning challenges into Golden opportunities.

Semex Guernsey Report for 2010

Pine Ridge Double L: Semex' highest LPI sire was also its most exported bull in 2010. He was 3rd in usage among proven GU bulls across Canada last year. He is a real specialist in components and in the mammary system, but needs to be used on a strong smooth-rumped cow.

Millborne Bolero: This proven veteran maintained good popularity during 2010 being the second most demanded bull in Canada and the 3rd in volume of semen exported. He maintains high production and solid type ratings along with attractive SCC ratings. For best results he should be bred to high component females that do not have too much set to their rear legs.

Rutter Bros Lewis Louie: This Enhancer Lewis son became proven in April 2010 and quickly became Semex' most requested proven bull for the year. His breakdown shows him to be a very balanced breeding sire.

Knapps Mr America: This Enhancer son is one of Semex' top production sires, while transmitting improved mammary systems at the same time. He was Semex 4th most heavily requested proven sire in Canada during 2010 and had the same ranking in volume of semen exported among proven sires.

Land of Living RO Levi: This much anticipated Royal Oak son was returned to service following very successful proof information received in December. He is currently seeing much demand due to the beautiful frames and high production level that he delivers. With only 37 female offspring registered originally, we will not see a much larger daughter number in his first crop summary than he now carries.

Four Winds Showtime: This Fayette son from one of the best known Magicman daughters became proven in 2010. While not known for siring high production he is capable of siring the kind that can excel in the strongest of shows, as evidenced by his Premier Sire designation at World Dairy Expo in 2010, based on performance of several junior-aged and milking daughters. A number of these same animals went on to be nominated All-American.

The immediate member of the family, of a member of the Canadian Guernsey Association, under 21 years of age and residing at home is permitted to register animals at the regular rate granted to members of the Association using the tattoo letters of his or her parents and also the herd name of such, if being used by the parents, without becoming a member of the Association. The fact that the son or daughter so registering their animals must be supported by a declaration that their parent is a member of the Canadian Guernsey Association, their age status and the application endorsed by the parent. This declaration only to be presented with the first application for registration.
